ANBP was formed in 1990 by commercial insectaries to provide a united voice in regulatory issues facing the industry. ANBP is also dedicated to quality standards and educating the agricultural and academic communities about the importance of biological pest controls for pest management. ANBP membership exceeds 100, including 46 producers and/or suppliers. Through its efforts, ANBP is recognized as ***THE*** spokesman for the commercial biological control industry.

Regulatory Report:

(By Dan Cahn, Chair, Regulatory Committee)

As mentioned in our last issue, ANBP is hoping to free biological controls being imported into the US, from the dreaded PPQ 526 permit process. The "pest permit" has always been a contentious issue for ANBP - never really appropriate for beneficial insects. ANBP has wrestled with an inconsistent and at times arbitrary process that never seemed to understand the unique nature of commercial products.

Through the North American Plant Protection Organization (NAPPO) we are hoping to see Canada, United States and Mexico agree on a protocol that will categorize beneficial insects as a low risk commodity that can be regulated through phytosanitary certificates issued by the exporting country.

A draft protocol has been written and circulated for discussion at the next NAPPO meeting in October. For more information about NAPPO see www.NAPPO.org.

A remaining problem with APHIS is their intention to begin charging user fees for issuing PPQ 526 permits. We have not seen a fee schedule (if it exists) but Bob Flanders of USDA PPQ has stated that fees could be as high as \$1000 for new permits. This will be a serious damper on biological control experimentation and innovation. For example, there are currently several new biological control products that have been brought to market in Europe this year. There is a serious disincentive if a business in the US must pay \$1000 to import the first sample for trials. These huge fees are clearly at odds with the one of the goals of USDA to encourage and expedite biological control.

Even assuming the success of the NAPPO agreement to remove us from the old permit process, new biological control products will still be required to have PPQ 526 permits, perhaps for as long as five years.

ANBP has asked our Washington representative, Bob Gray, to investigate the status of the user fee proposal and give us options for contesting implementation.

The regulatory committee wishes a speedy recovery to our attorney, Aleen Rothschild-Sidel who underwent surgery last month.

News from Canada:

Applied Bio-nomics' Brian Spencer reports

I haven't had a chance to talk much with the other distributors and producers, but we have had a disappointing year. Cold weather in the early months and now very hot weather does not help a fragile balance in the greenhouses. There are numerous requests for minor use of non registered pesticide this year also. The trend is of great concern to our industry.

I am also concerned that we have not made any progress on the new NAPPO standard that I was the author of. It is still awaiting first reading and translating. I have not been able to find out where it is stuck.

In the good news category; Aphidoletes was introduced in Blueberries in B.C. with clear establishment, another agricultural crop that may join our fold. The fire's gone out in my wood stove, so I'm off. See you in Mexico.

ANBP Announces Annual Student Award

Commencing at our 2005 Conference and Annual General Meeting in Guadalajara, Mexico, ANBP will be awarding \$500USD for the best student paper on research relevant to augmentative biological control. This award will be presented annually at the AGM and/or at other related meetings as judged by a panel of producer members.

This award came about as an attempt to encourage communication with academia and support applied research that has tangible benefits to the commercial biocontrol industry. ANBP members have all-consuming businesses and often lack both the time and knowledge to think up research projects or indeed even to respond to surveys on such topics. Three years ago, a resolution was made to establish a research fund, maintained by donations and a portion of proceeds from the annual conference.

The size of the fund is not significant in terms of funding actual research projects, but is sufficient to offer awards to student papers. The existence of the annual student award will give ANBP an identity in the research community and raise awareness of research supporting the growth of augmentative biological control.

Fall 2005 ASTM E35.30 Meeting to be held in Guadalajara, Mexico The fall ASTM subcommittee E35.30 will be at the Hotel El Tapatio in Guadalajara, Mexico from 1 to 5 PM, October 13, 2005. (Telephone (33) 3837 29 29). This is the afternoon prior to the ANBP annual conference.

ASTM will have two venues in Guadalajara: first we will work on current projects at the ASTM meeting. Species discussed will include test methods with *Encarsia*, *Eretmocerus*, *Persimilis*, Fly Parasites, and the key issue of simple user tests vs. test methods used by experts to produce data that will be published as definitive assessments of product quality. Next at the ANBP conference., Carol Glenister, Anna Luczynski and Jan Nyrop will summarize past accomplishments

A special guest at both the ASTM meeting and the ANBP conference will be Guy Boivin from Agriculture Canada, a researcher that is studying parasitoid learning as influenced by environment. His observations are that female handling time falls dramatically as the females gain experience, but this can be disrupted by environment.

Report on the Spring 2005 ASTM E35.30 Meeting in Oxnard

The spring 2005 meeting presentations and discussion topics ranged from fitness to statistical analysis to international movement of our products. On fitness, Anna Luczynski presented *Encarsia* flight test results, noting that the flight test data had very low variability and if the product passed the flight test, then it was very unlikely to fail the numerical test.

Jan Nyrop summarized the statistical analysis of our *Cryptolaemus* counts in Colorado in fall 2004 and interpreted the fitness data that has been developed by Anna Luczynski and Ian Shi on *Encarsia*, *Eretmocerus* and *Phytoseiulus persimilis*. The Crypts were volumetrically measured units of 100 Crypt beetles packaged by The Bug Factory. He found that the Crypt counts were normally distributed with a mean of 125 and a 5% error rate. For the *Persimilis* data, it appears that the primarily female product is often quite old and not very fecund. Anna challenged producers to find a way to produce more fecund product.

Joe Vorgetts of USDA APHIS presented the current practices of regulating international movement of new, non-indigenous organisms for commercial biological control followed by an overview of the NAPPO (North American Plant Protection Organization) Biological Control Working Group. The review of new weed biological control agents (which are not likely to be commercial product) is the only well-established procedure in place and that is within the jurisdiction of APHIS. Actually, APHIS does not have authority over natural enemies that are not plant pests other than to declare that they are not plant pests.

A visioning session on the ideal mechanisms for international border crossings of biological control agents followed.

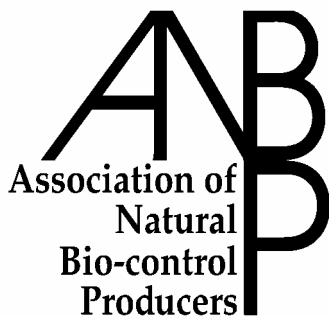
What do we want?

- International shipments movement
- Periodic:
 - species verification
 - purity verification
- Within one day border crossing
- ASTM document written by governed with government input
- Reviewed and voted every 5 years
- Permits that can be processed by DHS
- Gets across the border within a day (inspection at point of entry, no bonded carrier)
- Definition of the commercial biocontrol agent
- Reviewed government document (5 year review period)
- Periodic visitations to production facilities to confirm the production on site
- Lists of precedented organisms by country
- We need to have a clear set of rules
- Methods that work
- One day turn around on import permit for commercially precedented organisms
- Assure the regulating agency of compliance /purity/safety/non-pest status
- Recognition by regulators of low risk potential (standardized document, showing level of risk.) (Keep records of % infractions (sample for contaminants)
- A separate set of guidelines for international movement of commercial goods.
